MR PEDRO ORTEGA RODRÍGUEZ

(Canary Islands, 1961)

Currently

Regional Minister of the Economy, Industry, Trade and Knowledge Canary Islands Government

Professional Profile

He graduated in 1984 in Biological Sciences from the University of La Laguna, Tenerife, specialised in Food Science and Engineering by completing a Master at the Technical University of Valencia (1985-1987).

He attended several specialization courses in Food Technologies between 1992 and 1995 at the Buhler Research and Development Centre, among others Uzwil (Switzerland) and Caliano (Italy).

In 1988, assumed the direction of the Department of Dietetics-Sanitary (Dietética-Sanitario)

Subsequently, he assumed the Technical Direction of the Section - Chocolates of the Company Andrés Megías Mendoza. He became General Director of this company, a position that he held until July 2015, when he was appointed Councillor of Economy, Industry, Commerce and Knowledge of the Government of the Canary Islands.

From 2002 to 2010 Lloyd's Register Quality Assurance Limited Lloyd selected him as Technical Expert in the Canary Islands

Pedro Ortega has combined his professional and teaching activities, being a part-time Associate Professor of the Department of Animal Pathology, Animal Production, Bromatology and Food Technology at the University of Las Palmas de Gran Canaria (1990-2004).

Institutional Activity

In 2004, he was appointed Secretary of the Spanish Association of Manufacturers of Pasta.

He has also been Regional President of the Industrial Association of the Canary Islands, holding this position in 2005, 2007 and 2009. He has also been Provincial President of the Canary Islands Industrial Association for the period 2005-2010.

In 2005 he was elected Treasurer of the Canary Islands Confederation of Businessmen, a position he held until his appointment as Director of the Canary Islands Government in July 2015.

From 2011 until his appointment as Director of the Government of the Canary Islands in July 2015, he has been a member of the Executive Committee of the Chamber of Gran Canaria.

Pedro Ortega was Director of the Canary Islands Economic and Social Council from 2007 until his appointment as Director of the Canary Islands Government in July 2015 and President of the Arucas Economic and Social Council from 2012 to 2015.

Since July 2015 he has been Minister of Economy, Industry, Commerce and Knowledge of the Government of the Canary Islands.



MR DOMINIQUE RISTORI

(France, 1951)

Professional and Political Profile:

Dominique Ristori has been working in the European Commission since 1978 where he has held several positions. Prior to his current position, he was Director- General of the Joint Research Centre (JRC) (2010-2013).

Between 2006 and 2010 Dominique Ristori was Deputy Director General of the Directorate General for Energy.

Whilst Director in charge of General Affairs and Resources at Directorate-General for Energy and Transport (2000 - 2006), he was responsible for interinstitutional relations; enlargement and international relations; coordination of energy and transport research; internal market, state aids, infringements and public service obligations; passengers' and users' rights; central management of human and budgetary resources. Between 1996 and 1999, he was Director in charge of European Energy Policy at Directorate-General for Energy.

Dominique Ristori played an important role in the preparation and adoption process of the two first Directives on the Internal Market for gas and electricity. He launched also successfully the Florence and Madrid Forum for electricity and gas at the origin of the regulatory process in the energy sector.

In the period of 1990 – 1996 Dominique Ristori was in charge of transnational cooperation between SMEs at the Directorate-General for Enterprise policy.

Dominique Ristori graduated from the Institute of Political Studies of Paris (1975).



MR FERNANDO CLAVIJO BATLLE

(Canary Islands, 1971)

Currently

President of the Canary Islands

Professional Profile

Mr. Clavijo graduated from the University of La Laguna in Economics and Business Studies. He has worked in the private sector, combining this activity with his studies. He has been an advisor for the Musical Activities Agency of the City Council of San Cristóbal de La Laguna, as well as councilor for Citizen Security from 2003 to 2007.

From that year until his appointment as mayor (the youngest in the history of the municipality) in November 2008, he was first deputy mayor and council member of Urbanism.

During his time as mayor of the municipality, Fernando Clavijo promoted the Special Plan for the Protection of the Historic Centre and the model of the Open Commercial Zone. These actions earned him the awards from the Ministry of Culture, Ministry of Industry, and Ministry of Tourism.

During his term, La Laguna won the Reina Sofía Prize Against Drug Addiction and achieved consideration as one of the first cities in Spain with the highest quality of life.

He has been in politics since 1992, having been general secretary of the Canary youth movement (Las Juventudes de CC) and, later, president of the Local Group of the Canary Coalition in La Laguna. In 2012, he was elected general secretary of the Canary Islands Coalition in Tenerife.

Since July 2015, he is the President of the Government of the Canary Islands.



MR JOE MIZZI

(Malta, 1952)

Currently

Minister for Energy and Water management, Malta

Professional activity

He started his career working as a Technician/Operator in the Computer Room based on a ship dedicated to Seismic Surveys (Oil Exploration) in the Maltese territory between 1971 and 1972.

Later, he was engaged as a Radio Officer on merchant ships where he continued until 1975 when pursued his techniques in the sector of Telecommunications up to 1992, holding the post of Senior Technician with Deutsche Welle Radio.

In 1983 he was nominated by the Labour Government in the setting up and formation of RTV Ltd, where he later served for a number of years as the Technical Director representing the government side.

Joe Mizzi became active in the Malta Labour Party in 1975, when he joined as a member in the Kalkara Youth section of the Malta Labour Party and he was appointed Propaganda Secretary. Mizzi started his parliamentary career within the Malta Labour Party when he contested Malta's general elections for the first time in 1987 and was elected in the 2nd District.

He was subsequently elected member of Parliament in the General Elections of 1992, 1996, 1998, 2003, 2008 and 2013, representing the Second Electoral District. From 1989 until 2013 he served as Secretary of the Labour Parliamentary Group and a Member of the Administration of the Malta Labour Party. In 1996, the Labour Party won the general elections and Mizzi was appointed Minister at the Office of the Prime Minister, with responsibilities for Police, Home Affairs, Telecommunications and Oil Exploration, a position he held until the general elections of 1998.

Between 1998 and 2008 Mizzi was assigned the role of Shadow Minister for Environmental Planning and Oil Exploration, Shadow Minister for Infrastructural Services and Oil Exploration, which responsibilities also included Enemalta, Water Services Corporation, Telecommunications, the Malta Maritime Authority and MaltaPost.

From 2009 to 2013 he was the main spokesman for Transport, Resources and Oil Exploration, including the Malta Maritime Authority and Malta International Airport.

In March 2013 the Labour Party won the general elections and Mizzi was appointed as Minister for Transport and Infrastructure. In the last General Election, Joe Mizzi was appointed Minister for Energy and Water Management.

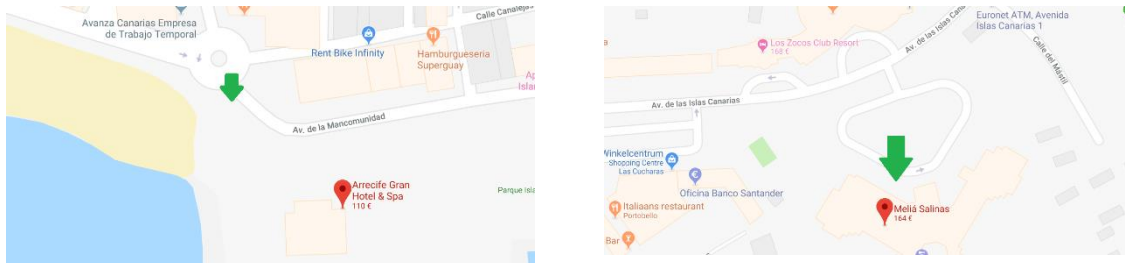
