Editorial

Welcome to the Summer!

With petrol prices rising due to the new geopolitical reality of war in Europe, we need to drastically accelerate the clean energy transition and increase Europe's energy independence.

REPowerEU is the European Commission's plan to make Europe independent from Russian fossil fuels well before 2030, considering Russia's invasion of Ukraine.

[85% of Europeans](#) believe that the EU should reduce its dependency on Russian gas and oil as soon as possible to support Ukraine. By acting as a Union, Europe can achieve this faster.

The REPowerEU plan sets out a series of measures to rapidly reduce dependence on Russian fossil fuels and fast forward the green transition while increasing the resilience of the EU-wide energy system.

Next to diversifying energy supplies and energy saving, accelerating clean energy is one of the key actions. Renewables are the cheapest and cleanest energy available and can be produced directly on the islands, reducing the need for energy imports. This is where the EU islands secretariat comes in, supporting islands in their energy transition. The secretariat is working to reduce dependence on imported oil, even more, urgent than before.

Clean energy for EU islands forum 2022 - Key Facts and Figures




